## record re sets

Even Vice President and presidential candidate Al Gore doesn't talk about the fact that he and President Clinton kept a promise of devising "a government that works better and costs less." He should. Congress set procurement reforms to simplify government buying. Projected fiveyear savings: \$22.5 billion. Pentagon procurement practices, the kind that made \$700 toilet seats and \$800 hammers famous, were cleaned up so that supply sargeants can now go to Wal-Mart, if need

be. In the eight years Reagan and Bush were in office, the waste, fraud and abuse in Pentagon procurement practices were never touched.

The Office of Personnel Management ditched 10,000 pages of regulations, promising managers more sway over hiring, firing and promotions, making it easier to fire incompetent federal employees.

Four federal services the public meets routinely, the Internal Revenue Service, Social Security Administration, Postal Service and Veterans Affairs Department. announced new, higher standards for customer service. After that time, the IRS actually surpassed it's goal of delivering refunds in 40 days.

Tens of thousands of bureaucrats were offered buy-outs of up to \$25,000. How much of the deadwood hung on, we don't know, but if they did, it's the taxpayers who lost.

Presidential candidate Gore represents an administration that spearheaded and passed the Family Leave Act, the national youth service program, already bigger than the Peace Corps at it's peak, an improved and expanded college loan program with a better repayment rate, the Brady bill, the assault-weapons ban (before Columbine), the motor-voter law making it easier to register to vote.

And I think Vice-President Gore's handling

were first class. He was loyal. There isn't a person alive who thinks Gore approved of President Clinton's behavior. Al Gore isn't a cutsy, fraternity president type like George Dubya, Gore is, in a word, presidential,

Now let's just check some figures from the State of Texas. According to figures distributed by the AFL-CIO, Texas rates 50th in spending for teacher's salaries, 49th in spending on the environment, 1st in percent of poor working parents without insurance, 47th in delivery of social services, 42nd in child support collections, 5th in percentage of population living in poverty, 1st in percent of children without insurance. 48th in per capita funding for public health, 1st in air and water pollution levels, 41st in per capita spending on public education, and 1st in executions, (average one every two weeks for Bush's five years as governor.)
